Executive Summary

The Stage 1 Preliminary Site Investigation (PSI) was conducted to ascertain contamination risk for the Cleve Wind Farm (CWF) site, which spans approximately 23,900 hectares across the localities of Cleve, Rudall, Campoona, and Kielpa. This investigation involved a desktop review of site characteristics, environmental setting, and historical and current land uses. Based on the findings, a preliminary Conceptual Site Model (CSM) was developed to identify potential sources, pathways, and receptors of identified potential contamination.

The site is primarily used for dryland agriculture, cropping, grazing on modified pastures, and conservation. Surrounding land use is largely agricultural, with adjacent conservation parks such as Rudall and Yeldulknie, and the Yadnarie Substation located to the south. Historically, the site has been used for similar activities, including cropping, grazing, and conservation. Reviews of South Australia (SA) Environment Protection Authority (EPA) records did not identify any known existing site contamination issues.

Potentially Contaminating Activities (PCAs) were identified, both on-site and off-site:

On-site:

- o Agricultural activities, including the use of fertilisers, herbicides, and pesticides.
- General site works, such as the storage and use of vehicles and generators.
- o General site use, including herbicide application along roads for weed control.

Off-site:

 Utilities infrastructure, particularly the Yadnarie Substation, which may involve electrical equipment and associated chemicals.

The likelihood of significant contamination impacts to identified receptor is assessed as low, given the localised nature of the identified PCAs and their limited intersection with planned project works as the installation of the majority of the infrastructure will be on ridges or away from existing agricultural infrastructure. However, targeted soil sampling should be undertaken prior to construction commencing to inform potential risk to site workers, and classification of waste soils, should off-site disposal be required.

In addition, it is recommended that management measures are implemented during the construction, operation, and maintenance phases of the CWF to prevent exposure to persons undertaking the works and spread of impacted soils to non-impacted areas.

1.0 Introduction

1.1 Background

AECOM Australia Pty Ltd (AECOM) has been engaged by Cleve Wind Farm Pty Ltd (being a related entity of Vestas Development Australia Pty Ltd [Vestas]) to undertake a Stage 1 Preliminary Site Investigation (PSI) across 72 parcels of land on the Eyre Peninsula to the north-west of the township of Cleve, of which the Cleve Wind Farm project (CWF) is to be situated ('the site').

1.2 Project description

The CWF is a large-scale renewable energy generation and storage project comprising:

- Wind farm up to 500 mega watt (MW), consisting of approximately 70 wind turbines.
- 240 MW (approx.) battery storage facility
- Substation
- Associated on-site facilities and infrastructure, including:
 - Turbine pads
 - Crane hard stands pads (for construction)
 - Internal road network upgrades and new roads to accommodate turbine transport and maintenance.
 - Construction compound
 - Concrete batch plant
 - Operations and maintenance (O&M) building

1.3 Objective

The objective of the Stage 1 PSI was to ascertain contamination risk for the site by reviewing site history and site setting information to assessment.

1.4 Scope of work

The following scope of work was completed for this Stage 1 PSI:

- Desktop review of site characteristics site location, site layout, and the environmental setting.
- Desktop review of historical and current site owners, occupiers, land uses and potential for contamination causing concerns.
- Review of South Australian Environment Protection Authority (EPA) publicly available information relevant to site contamination, including a Section 7 search.
- Identification of potentially contaminating activities (PCAs) within the site and associated chemicals of potential concern (CoPC).
- Development of a preliminary conceptual site model.

This Stage 1 PSI has been prepared in accordance with relevant industry standards and guidelines including:

- National Environment Protection (Assessment of Site Contamination) Measure 1999 (as amended 2013) (ASC NEPM).
- SA EPA publication 'Guidelines for the assessment and remediation of site contamination,' as revised November 2019.

Environment Protection Regulations 2023 (SA) (EP Regulations)

2.0 Site information

2.1 Site identification

The site is comprised of 72 land parcels under 55 Certificates of Title (CT). Details of the current Certificates of Titles and their descriptions are summarised in Table 1.

2.2 Site description and current land use

The CWF site spans across approximately 23,900 hectares and is situated in the localities of Cleve, Rudall, Campoona, and Kielpa. It supports a mix of land uses, including dryland agriculture, plantation forestry, conservation areas, and grazing on modified pastures.

2.3 Surrounding land uses

Surrounding land use primarily consists of agricultural activities, including cropping and grazing pastures. To the west, the site borders Rudall Conservation Park, a designated reserve. Utilities infrastructure, the Yadnarie Substation, is located south of the site. Additionally, the Birdseye Highway borders the south of the site, connecting to Cleve in the east and Rudall in the west.

The Yeldulknie Conservation Park is located approximately 2.5 km to the east of site's eastern boundary. Additionally, two land parcels designated for rural residential use in the east are bordered by properties included in the CWF site.

3.0 Environmental setting

3.1 Topography

The site's topography was assessed using 1-second Shuttle Radar Topography Mission (SRTM) derived Digital Elevation Model data (Geoscience Australia 2015). The site's elevation ranges from 127 m to 399 m based on the Earth Gravitation Model (EGM96).

The lowest point is in the southwest, while the highest elevation is along the site's eastern side. The mean elevation is 264 m EGM96.

See Figure 1, Appendix C for a visual representation of the site's topography.

3.2 Regional geology and soil

3.2.1 Surface geology

A 1:2,000,000 scale geology map viewed on the South Australian Resource Information Gateway (SARIG)(SARIG 2024) indicates that the following units characterise the surface geology of the site:

- QE (Quaternary aeolian sediments) Aeolian sand from inland dune fields
- QYi1 (Middleback subgroup unit 1) Iron formation.
- J-o (Polda formation) Fluvial sandstone and conglomerate.
- Qpa (Pleistocene alluvial/fluvial sediments) Gravelly and sandy clay of piedmont slopes and alluvial plains, commonly gypcrete or calcrete
- Yh (Hutchinson Group) Quartzitic, pelitic, and calcsilicate metasediments, including iron formation, marble, and amphibolite.
- Yhdw (Warrow quartzite) Quartzite, pelitic schist, minor conglomerate, and calcsilicate.
- Ytb (Blue Range beds) Sandstone and conglomerate.
- Yz (Peter Pan Supersuite) Felsic and minor mafic intrusive rocks from the Kimban Orogeny

3.2.2 Soil classification

A review of the Atlas of Australian Soils data in the Australian National Soil Information System (ANSIS) (ANSIS 2024) indicates that the natural soils across the site are of the sodosol order, with chromosol and tenosol as subdominant order.

3.2.3 Acid sulfate soils

The National Acid Sulfate Soils data in ANSIS indicates that the probability of acid sulfate soils (ASS) occurring across the property is classified as B4 – low probability of occurrence with very low confidence (ANSIS 2024).

3.3 Hydrology

Hydrological features at the site were assessed using the DEW's 'Nature Maps' website (DEW 2024). Numerous watercourses and waterbodies are present within the property, including Yadnarie Creek, Poolalalie Creek, Mangalo Creek, Gum Creek, Sheoak Creek, and Salt Creek. Waterbodies within the site are primarily associated with these creeks and farm dams.

The Groundwater Dependent Ecosystem (GDE) mapping from the Bureau of Meteorology (BOM 2019) identified the creeks as aquatic GDEs within the site. Additionally, multiple terrestrial GDEs are likely present, including:

- Allocasuarina forest and woodland.
- Eucalyptus forest and woodland.
- Eucalyptus mallee forest and mallee woodland.

Melaleuca shrubland >1m.

No Ramsar wetlands were identified within a 5 km radius of the site (DCCEEW 2024).

3.4 Regional hydrogeology

A desktop review of groundwater conditions within the site's vicinity was conducted using SARIG (SARIG 2024). The depth of groundwater across the site is expected to range from 5 m to 500 m below ground level (BGL). Approximately one-third of the site is expected to have groundwater depths between 20 m and 500 m. See Figure 2, Appendix C for a map showing the depth to groundwater across the site.

Based on SARIG data, the salinity of the shallow groundwater is estimated to range between 3,000 and 35,000 mg/L total dissolved solids (TDS). See Figure 3, Appendix C for a map showing the groundwater salinity across the site.

3.4.1 Registered groundwater bores

A desktop review of registered groundwater bores located on the site was undertaken using Water Connect (Water Connect 2024). The search identified approximately 1,160 registered bores within the site. Of these, only one bore had a recorded use, which was for stock purposes.

Based on data from four bores, standing water levels (SWL) ranged from 6.55 m to 19.81 m BGL. TDS concentrations, recorded in ten bores, ranged from 1,514 mg/L to 26,418 mg/L.

3.5 Climate

Climate data sourced from the Bureau of Meteorology (BoM 2024) for the Cleve weather station (018014) spanning from 1991 to 2020 indicated the following:

- The mean annual maximum temperature is 22.5°C.
- The mean annual minimum temperature is 11.9°C.
- The mean annual rainfall of 402.1 mm.

3.6 Natural hazards

The site is within the Upper Eyre Peninsula Bushfire Management Area (Upper Eyre Peninsula Bushfire Management Committee 2024). There are no records of historical bushfires within the site, however there is one record east of the site, within Yeldulknie Conservation Park. This was a prescribed burn of 225 ha in 2014 (Data.SA 2020).

The land parcels with the site have the 'Flooding – Evidence Required' overlay in the Planning and Design Code, which applies to areas where flood mapping is not available and the potential risk of flooding is unknown (PlanSA 2024).

4.0 Site history

The site's history has been assessed to identify the current and past site activities, and a limited site history investigation was undertaken to understand former site uses and CoPC.

4.1 Current owners and occupiers of the site

An ownership search was conducted on the current CTs to assess the potential for site contamination from present land uses. The search also considered potential historical land uses that may have contributed to contamination risks, providing context for further environmental assessments.

The current ownership of each CT has been reviewed. Due to the large size of the site and the number of individual CTs, conducting a comprehensive historical analysis of each land parcel was not feasible. The current CTs show that much of the land within the site is owned by multiple owners, likely related families, with at least one company listed in association with agricultural activities. No land parcels are designated as pastoral leases.

One land parcel, CT5767/524, is Crown Land managed by the Minister for Environment and Water. It contains Railway Dam, a reservoir associated with the Eyre Peninsula Railway, which passes through Rudall to the west of the site (SAPPA 2024).

Additionally, two CTs, 5458/988 and 5480/560, include Significant Environmental Benefit (SEB) areas within their parcels, with CT5480/560 also having a Native Vegetation Heritage Agreement. These areas are managed by the landholders to protect and preserve native vegetation.

4.2 Historical aerial photography review

Historical aerial photographs of the site from 1985 to 2024 have been sourced from Google Earth (Google Earth 2024) and have been summarised in Table 3 below. See Appendix D for the aerial imagery.

4.3 SA EPA records

4.3.1 Site Contamination Index

A search of the SA EPA's Contamination Index (CI) did not identify any Section 83A sites or Groundwater Prohibition Areas (GPA) orders on the site or within a 1 km radius (EPA 2024b).

4.3.2 Public register

4.3.2.1 Environment Protection and Clean-up Orders

A review of the EPA Orders database found no Environment Protection Orders (EPO) or Clean Up Orders (CUO) orders on the site or within a 1 km radius (EPA 2024a).

4.3.2.2 Licensed activities

A search of the SA EPA licensed activities did not identify any authorisations within a 1 km radius of the site (Data.SA 2022).

4.3.2.3 Waste management facilities

There are no records of EPA-licensed waste management facilities, such as listed waste production sites, incineration plants, sewage treatment works, resource recovery or transfer stations, waste or recycling depots, or waste transport facilities, either within the site or a 1 km radius (Data.SA 2022).

The nearest facility is located approximately 2.85 km west of the site in Cleve. This facility is licensed for resource recovery and waste disposal under EPA license 28643.

4.4 Summary of site history

The CWF site has a history of consistent agricultural and conservation use since at least 1985, including cropping, grazing, and native vegetation protection. Ownership records indicate predominantly private landholders, with one Crown Land parcel and areas protected for environmental benefits. Aerial imagery from 1985 to 2024 shows minimal changes in land use or infrastructure. No significant contamination issues or waste facilities were identified within a 1 km radius.

4.5 Review of site history data sources

The sources of data reviewed for the site history are listed below in Table 4 along with a comment on the integrity of the source.

5.0 Preliminary conceptual site model

5.1 Elements of a conceptual site model

A preliminary conceptual site model (CSM) has been formulated utilising available information to determine the presence of plausible exposure pathways and hence the presence of significant risk to susceptible receptors such as humans, ecosystems or the built environment. For a significant or identifiable risk to exist an exposure pathway must be present which requires each of the following to be identified:

The presence of substances that may cause harm (SOURCE).

The presence of a receptor which may be harmed at an exposure point (RECEPTOR); and

The existence of means of exposing a receptor to the source (EXPOSURE ROUTE).

In the absence of a plausible exposure pathway there is no risk. Therefore, the presence of measurable concentrations of chemical substances resulting from previous site activities does not automatically imply that the impacts will cause harm. For this to be the case a plausible exposure pathway must be present allowing a source to adversely affect a receptor. The nature and importance of both receptors and exposure routes, which are relevant to any site, will vary according to its characteristics, intended end-use and its environmental setting.

5.2 Identified or potential sources of site contamination

The following potential sources of contamination have been identified based on the site's historical and current land use:

5.3 Potential transport mechanisms and exposure routes

The main transport mechanisms and exposure routes that could be feasible for current and potential future use(s) of the site are:

- Via dermal contact and incidental ingestion by on-site workers.
- Downward leaching of contaminants within shallow soils to groundwater resulting in contamination of groundwater.
- Airborne migration of soil particles leading to inhalation.
- Migration through groundwater and discharge into the marine environment.
- Dermal contact and ingestion of groundwater in the event of groundwater extraction.

5.4 Potential receptors

The following key site-specific receptors are feasible:

- Current site users and visitors.
- Future construction / maintenance workers at the site.
- Future occupants / users of the site.
- Groundwater dependent ecosystems.
- Agriculture.

5.5 Plausible exposure pathways

Table 6 outlines possible links between human health and ecological receptors, and exposure pathways at and in the vicinity of the site.

6.0 Conclusion and recommendations

The Stage 1 PSI was conducted to ascertain contamination risk for the site, which spans approximately 23,900 hectares across the localities of Cleve, Rudall, Campoona, and Kielpa. This investigation involved a desktop review of site characteristics, environmental setting, and historical and current land uses. A preliminary CSM was then developed based on this assessment.

The land uses of the site include dryland agriculture and cropping, grazing on modified pastures and conservation areas. Surrounding land use is primarily agricultural, with adjacent conservation parks such as Rudall and Yeldulknie and the Yadnarie Substation to the south.

Historically, the site has been used for cropping, grazing, and conservation. Reviews of SA EPA records did not identify any known existing site contamination issues.

PCAs were identified on and off-site, and included:

- On-site
 - Agricultural activities Use of fertilisers, herbicides, and pesticides.
 - General site works Storage and use of vehicles and generators.
 - General site use Application of herbicides along roads to control weeds.
- Off-site
 - Utilities infrastructure Electrical equipment and associated chemicals.

The likelihood of significant contamination impacts to identified receptor is assessed as low, given the localised nature of the identified PCAs and their limited intersection with planned project works as the installation of the majority of the infrastructure will be on ridges or away from existing agricultural infrastructure. However, targeted soil sampling should be undertaken prior to construction commencing to inform potential risk to site workers, and classification of waste soils, should off-site disposal be required.

In addition, it is recommended that management measures are implemented during the construction, operation, and maintenance phases of the CWF to prevent exposure to persons undertaking the works and spread of impacted soils to non-impacted areas.

Conclusions should be read in conjunction with the statement of limitations in Section 8.0.





Figure 1 Cleve Wind Farm site topography


Cleve Wind Farm - Depth to Groundwater
